INFORMATION LETTER

We hereby express our respect to you and inform you that the International Consumer Cooperative Light Great Russia (hereinafter referred to as the ICC LGR) being a Sovereign Subject of International Law, was founded in July 2018. Since March 16, 2019, the ICC LGR was registered with the United Nations, namely with the Secretariat General and the 26 main Organizations and Commissariats of the UN General Assembly, as a result of which the ICC LGR has been assigned a registration number in the UN system No. 602009.

We also would like to explain that the ICC LGR is fundamentally distinct in its legal foundation from legal entities both in Russia and in other countries, and is a free Sovereign Society that is not subject to taxation.

Based on the above, as well as on the norms of international law and the legislations of countries, the total number of shareholders of consumer, mutual and cooperative societies falls under the law on non-disclosure of personal data. We also inform you that the total number of shareholders in the ICC LGR today is about a million subjects and is constantly growing. In this regard, any proposals to disclose this information are illegal, and it is equivalent as if any financial institution is offered to transfer the client database.

Please note that the International Consumer Societies can legally have their own Treasuries (not controlled by an external regulator) and all shareholders of the International Consumer Societies automatically have their accounts in this Treasury. Information about the availability of accounts and accounting of installments, as well as settlements within the Treasury falls into the category of banking and treasury secrets. The Treasury of the International Consumer Society itself is the regulator of accounting for the movement of all types of installments.

We also inform you that any account opened in any bank or financial institution by an International Consumer Society or by the Treasury of this Society is a treasury account of a Sovereign Society, and it cannot be blocked by a bank or a financial organization without a decision of the International Court or an order of the Society itself.

The ICC LGR are determined to establish an inclusive and transparent international process on sustainable development goals in the world, open to all stakeholders, to develop global sustainable development goals. The eradication of poverty is the greatest global challenge of our time and a necessary precondition for sustainable development. Poverty eradication, changing unsustainable patterns of consumption and production and promoting sustainable patterns, and protecting and managing the natural resource base for economic and social development are central objectives and vital conditions for sustainable development. The ICC LGR is at the center of the world's development processes, bearing a great responsibility today in the World, and in this regard, the participants in the ICC LGR have been committed to strive for a just, equitable and inclusive World and work together to promote sustained and inclusive economic growth, social development and environmental protection for all, in particular children, youth and future generations throughout the world, without distinction of any kind, whether on the basis of age, gender, disability, culture, race, ethnicity, origin, migratory status, religion, economic or other status. Members of the ICC LGR had proclaimed the LAW of CREATION.

The implementation of the Sustainable Development Goals depends on the creation of global partnerships for sustainable development with the active participation of governments, as well as civil society, the private sector and the International Treasury M1 system. An essential element for the successful achievement of these goals is a robust implementation review mechanism. A key role in this regard is played by the *Sovereign Bank the Sovereign Military Hospitaller Order of Saint John of Jerusalem, Rhodes and Malta*, created by the efforts of the IPC, and a High-Level Political Forum.
